Company Profile

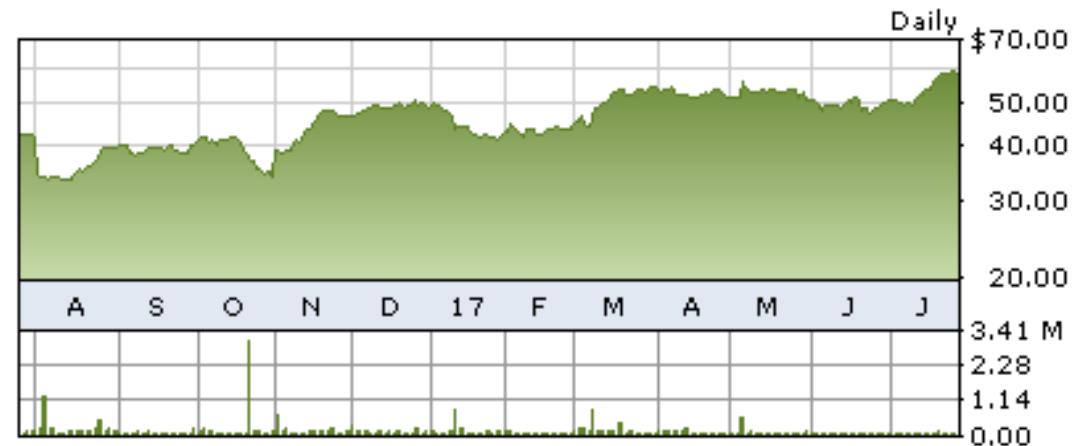
