## Company Profile

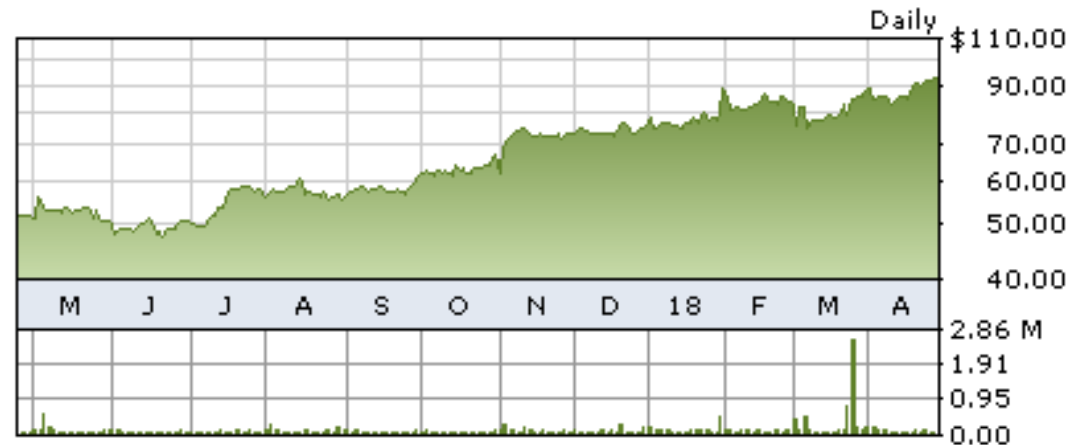
