Company Profile

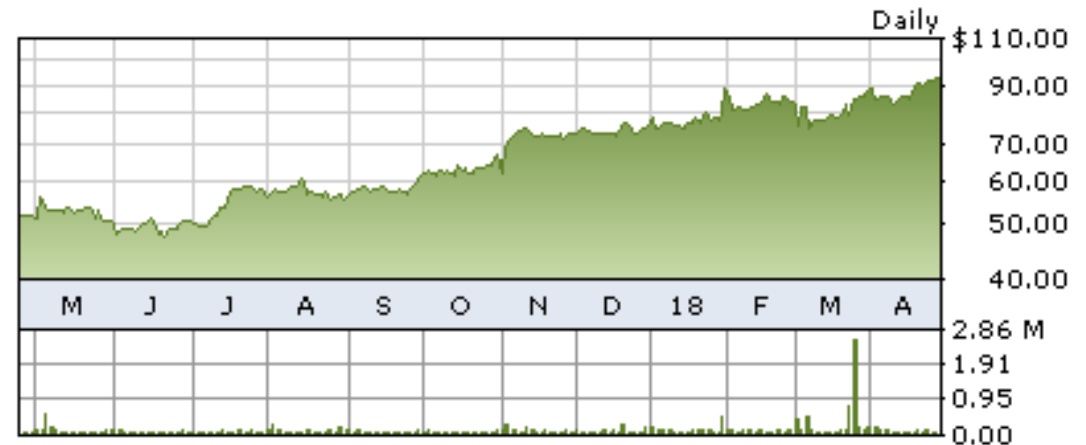
