Company Profile

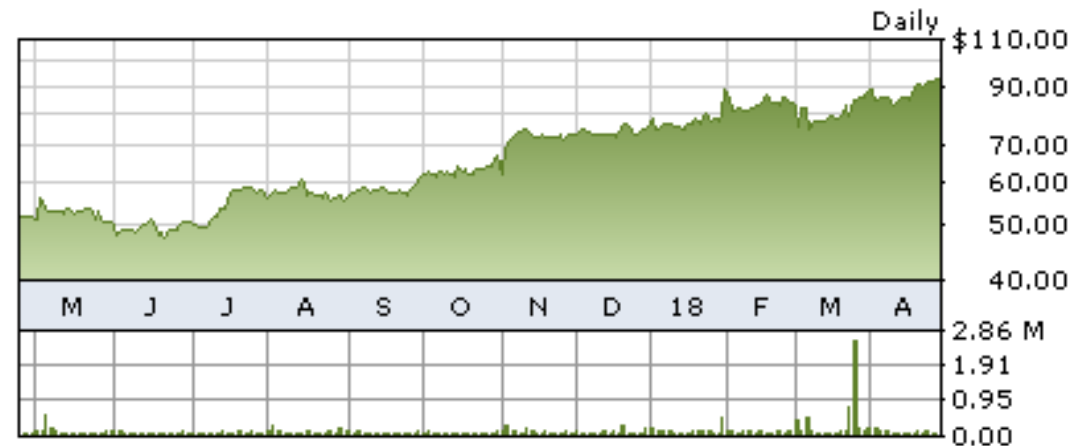
