Company Profile

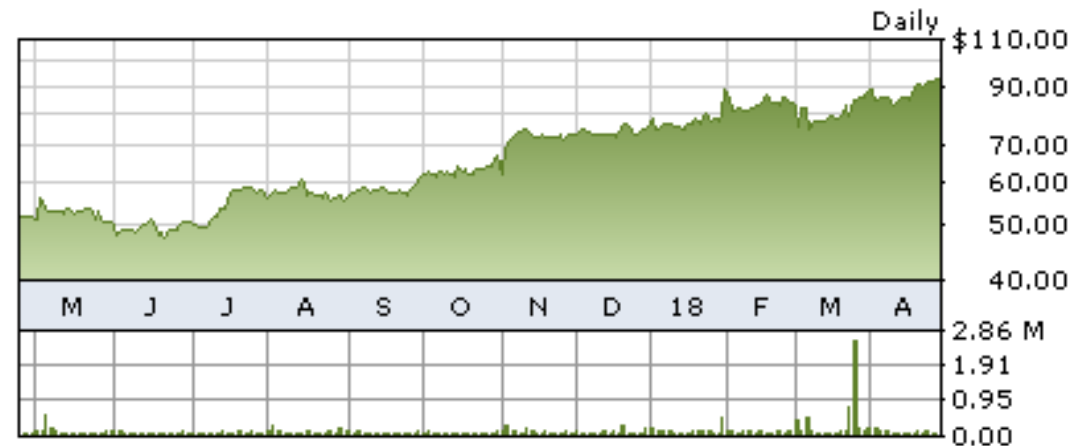
