Company Profile

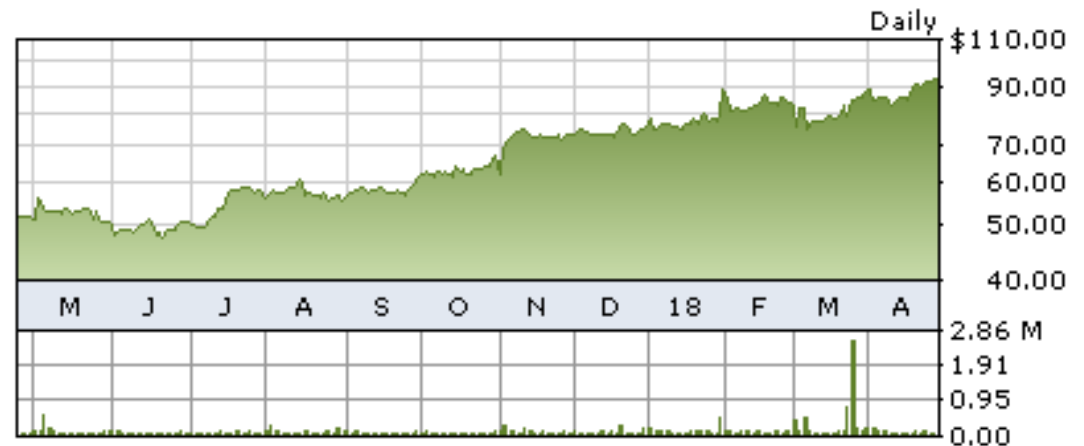
