## Company Profile

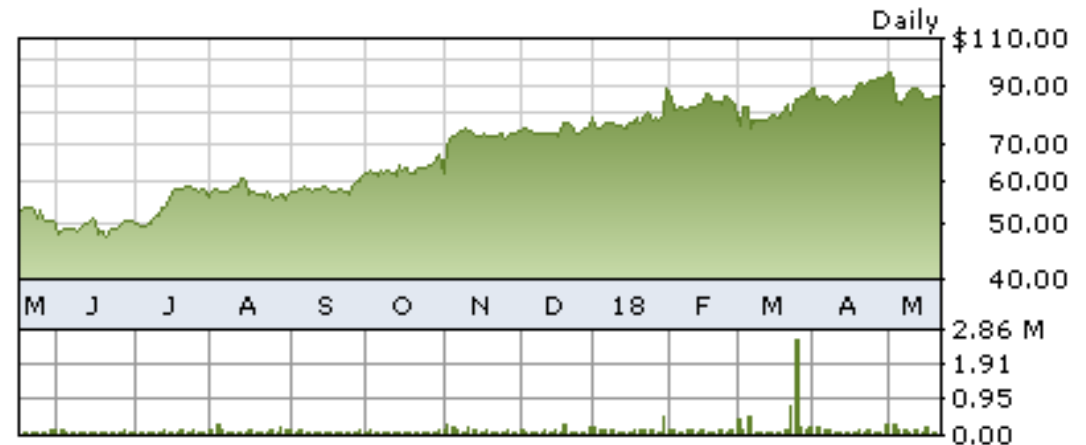
