Its products are used primarily for general lighting applications, including street lights and commercial, industrial and residential lighting. The company sells blue, green and ultraviolet (UV) LED chips under its MvpLED brand, primarily to customers in China, Taiwan and other parts of Asia. It sells its LED chips to packaging customers or to distributors, who in turn sell to packagers.
