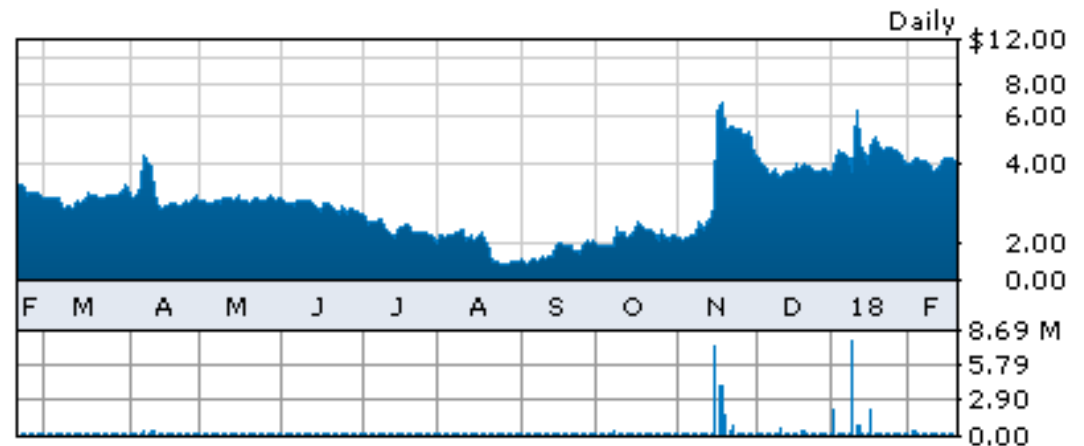

It sells its LED chips to packaging customers or to distributors, who in turn sell to packagers.
