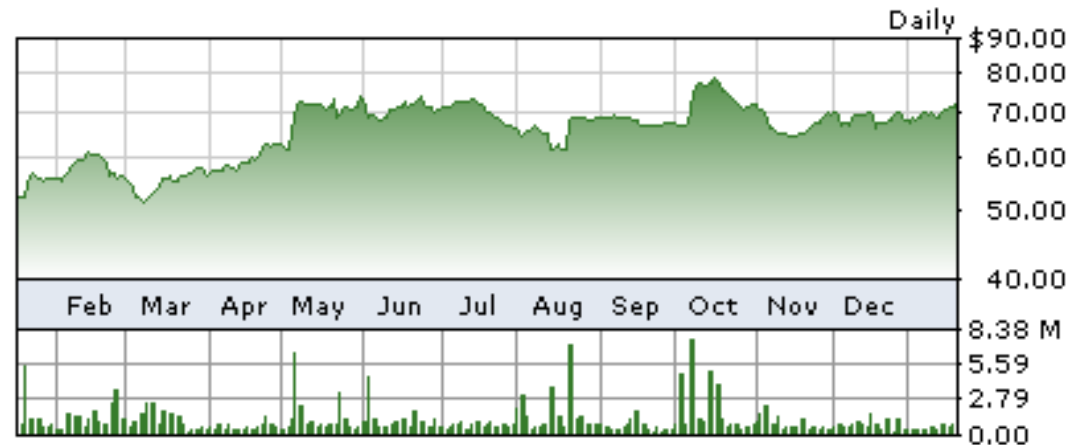
Company Profile
