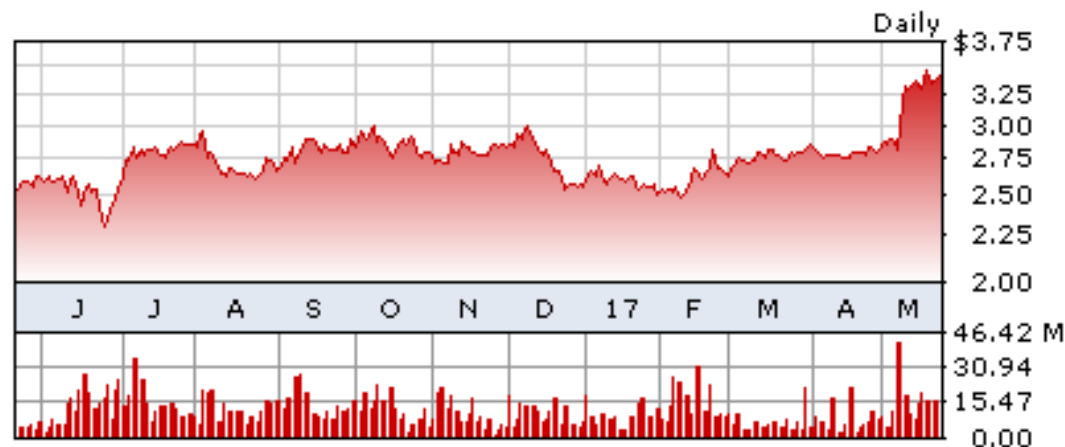
Company Profile
