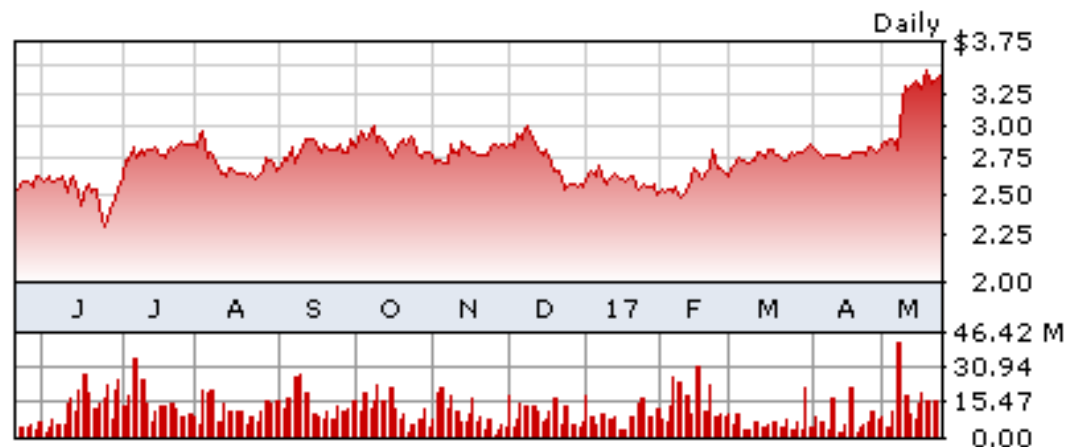
Company Profile
