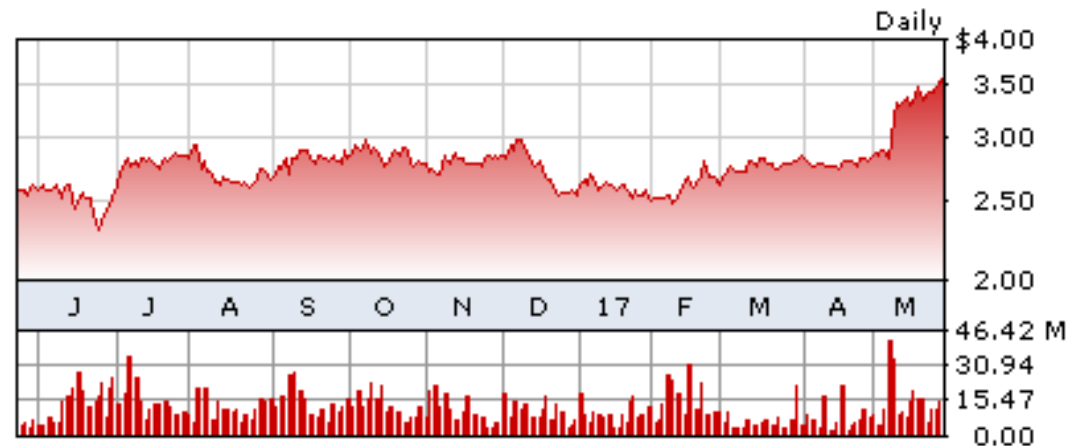
Company Profile
