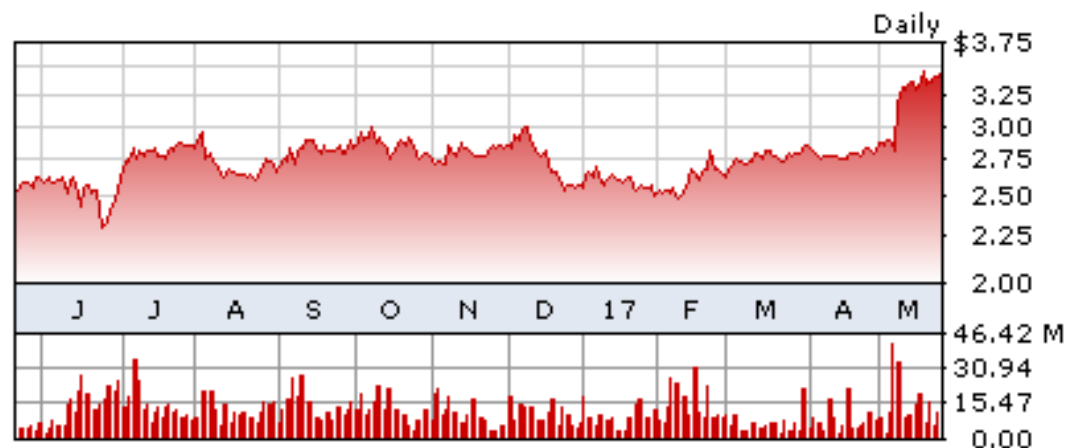
## Company Profile
