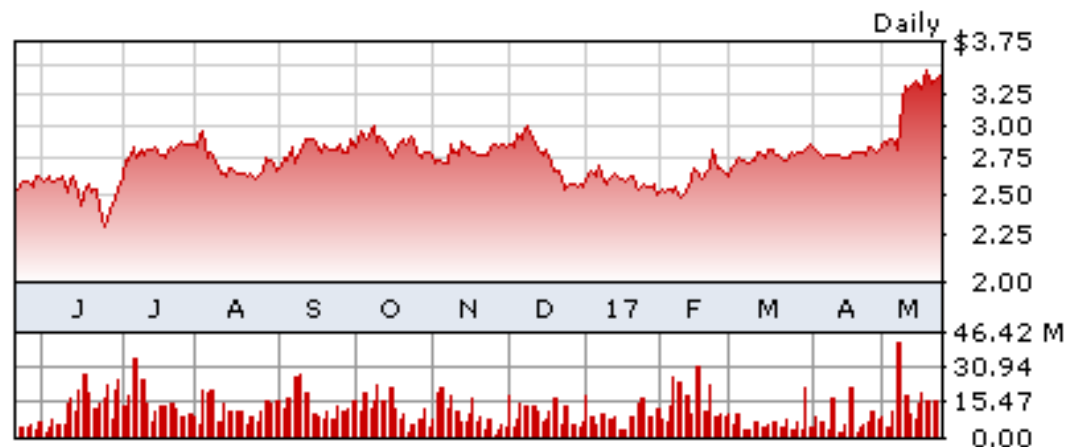
Company Profile
