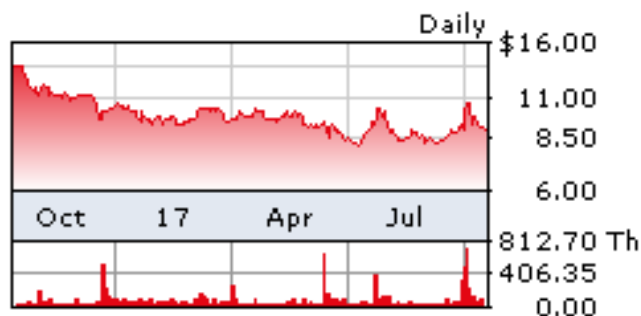
RedHill's products are based on several technology platforms and address several disease targets, thus providing for risk diversification.
